8. Treasurer's Report: Maxine Emm (Delta) Maxine presented her report and it was emailed to members. Kay Kurvers asked what Silver Spoon is. It is a designation given by the bank to non-profits which means no fees on an account.

Convention

Business of the state shall be conducted annually on odd years at a convention held at a time and place determined by the Alpha Chi State Executive Board, for the purpose of receiving reports and adopting policy, amending bylaws, electing officers and conducting other business which may properly come before it.

Marlene Killion asked what would happen to the Executive Board meeting that coincides with convention and would the Leadership training be around the same time as the Executive Board meeting.

Pat shared that they could be held on the same day. This would enable all members to participate.

According to the bylaws, Executive Board only needs to meet once per year. The plan is for the Executive Board to meet in the Fall, then in the Spring one week before convention.
